# • THE ASIALAWYERS •

## CONCEPT

The Asian Football Cup of bar associations and law firms, called «Asialawyers», is a tournament reserved to lawyers of the Asian continent.

Created in 2007, in addition to the Mundiavocat (Lawyers' World Cup), the event has significantly developed. The 3<sup>rd</sup> edition, in 2017, brought together 20 teams from 10 Asian countries! The competition, which takes place every two years, will be played out over four days in 2019, from Thursday to Sunday. The draw takes place on Wednesday night. Two eleven-a-side football tournaments are offered this year, Classic & Master, and each team plays between 4 and 5 matches, from 40 to 60 minutes, depending on the category and their progress in the tournament.

## REFEREEING

To ensure the smooth running of the competition, a regional association will provide the referees necessary for staging the 60 games in the tournament. Three referees and one delegate will be involved in each match.

## TROPHIES

**Prizes will be awarded in each tournament:**

- **Champions, runners-up, and 3<sup>rd</sup> place;** cups and medals (gold, silver, and bronze);
- **All other teams** will receive a cup with their relative ranking;
- **Special prizes will also be awarded in each category** for the best player, top scorer, best goalkeeper, best manager, and most sporting team.

## REGISTRATION

Any team representing one or more bar association or law firm is eligible to participate. There is no limited number per city or country, nor any qualification system.

# • BANGKOK

Bangkok is one of the premier tourist destinations in the world. The increasing number of travellers each year testifies to the fact that the city is indeed an unmissable tourist destination.

There is a wide variety of tourist sites in Bangkok, mainly historical attractions and temples with elaborate works of architecture and art. In addition to its famous temples, the city has palaces, museums, parks and a large number of shops to visit (from luxury shopping centres to flea markets such as weekend Chatuchak, Sampeng or the Pahurat Textile Market).

# • RATES •

Registration fees at the 4<sup>th</sup> edition of the Asialawyers consist of cost of registration per team and cost of stay per person.

## REGISTRATION FEES PER TEAM

### Eleven-a-side football - 2 500€

#### These costs include:

All expenses for the organisation of the tournament, the provision of football pitches, balls, refereeing (3 referees and 1 delegate per match), water on the pitch, touch-line medical assistance, cups, trophies, and medals.



## COST OF STAY PER PERSON

Rates per person based on a double/twin room shared by two people.

It is mandatory and non-derogatory, given the financial commitments made to our partners, to reserve your accommodation through the organisation when participating in the Asialawyers.

## I. TEAM REGISTRATION

**1.1.** The tournament is open exclusively to teams of lawyers from Asian bar associations, groups of bar associations, and law firms.

**1.2. Each team must include:**

- Eleven-a-side football: 13-26 players

## 2. ELIGIBILITY OF PLAYERS

### 2.1. Team formation

Each team must be made up taking into account the following provisions:

With the exception of cases of exemption referred to in section 2.2 below, all players must be:

- Lawyers registered (or previously registered) at a bar of the country of the registered team;
- Law students or trainee lawyers, over 22 years of age (born before 31/12/1997), within the limit of 2 per team for the Classic tournament.

### 2.2 Exemption principles

Exemptions may apply to the holders of a diploma of higher legal or judicial studies, and more generally permanent employees of law firms, insofar as they do not exceed four players for the eleven-a-side tournaments. In this case, a list including lawyers and non-lawyers, as well as a statement from the law firm certifying that the non-lawyers are permanent employees of the organisation must be provided.

These employees must be aged over 30 (born before 31/12/1989) in the Classic tournament and over 35 in the Master tournament (born before 31/12/1984).

### 2.3 Validation of exemptions

No exemption requests will be accepted for non-lawyers playing or having played football for a professional club, a semi-professional club, or any other club for payment. To be admissible, exemption requests should be sent to Mr Vincent Pinatel, founding lawyer of Mundiavocat, no later than 45 days prior to the start of the tournament.

All conditions set out above relating to exemptions are mandatory, but are not in themselves sufficient to guarantee an exemption. The final decision rests with the exemption commission, composed of Mr Pinatel and Mr Chicco (tournament director).

## 3. TEAM COMPOSITION

### Classic

- Lawyers with no age limit and in the cases mentioned above

### Master

- Lawyers who are over 35 years of age (born before 31/12/1984) and in the cases mentioned above
- 5 lawyer players over 30 years of age (born before 31/12/1989)
