Taking into consideration the constant dynamism of this industry, there are still multiple innovations that have, and which in the upcoming decade will continue to have, a crucial impact on fashion companies and that require a more sophisticated analysis, such as, for instance, the increasing relevance of selective distribution agreements, the challenges presented by globalisation, the introduction of blockchain, the use of 3D printers, artificial intelligence, the use of eco-friendly materials, etc.

The purpose of this seminar is to analyse the **new trends and challenges of the fashion industry for the next decade from a legal standpoint** alongside professional experts, highly recognised university professors of fashion law and in-house counsels of some of the main players in the fashion industry.
