

It is clear that in the wake of the 2008 financial crisis, there has been a marked shift in the policies of many governments to ensure that individuals "responsible" for wrongdoing, whether it is bank failures, tax evasion, anti-trust breaches, corruption or money laundering, should be, and are, prosecuted. Following on from last year's successful seminar on the 'Prevention of Criminal Liability of Directors and Corporates in France and Elsewhere', the Competition Law, Labour Law and Criminal Law Commissions of the UIA have come together to organise a joint seminar on the key developments in this area.

#### 11:30 – 12:30 Panel 3 – Radical Changes to Data **Protection Legislation**

This panel will explore how companies balance ever increasing obligations for data protection with the need to operate in a high tech environment. For example, the General Data Protection Regulation ("GDPR") - replacing EU directive EU/95/46/-is due to come into force in 2018, bringing with it wide-reaching implications for businesses in the way they process personal information. The GDPR aims to improve data security and encourage business leaders to be more vigilant when dealing with sensitive data. It will give regulatory authorities, particularly the information commissioner, additional powers to impose severe penalties on businesses, including third parties, and prosecute company officials in the event of a breach in data security.

After the Panama Papers, the leaked HSBC files in Switzerland and the Anti-Corruption Summit this year, this panel will explore the regulatory and enforcement trends for business in an unpredictable political and economic landscape. Is there a shift towards mandatory compliance procedures and is this really the solution for anti-corruption? A new EU Directive (2014/95/EU) – to be implemented by Member States by December 2016 - will require listed companies, banks and insurance companies to publish reports on non-financial information, including, inter alia, anti-corruption and bribery matters. The directive provides that report should include a description of the company's anti-compliance policies, the principal risks linked to the company's operations and how it manages those risks.

## 10:00 – 11:00 Panel 2 – Attorney Client Privilege: Key Considerations for In-House Counsel

This panel will consider whether attorney client privilege can be relied upon by in-house Counsel. Businesses that either on their own initiative or at the request of regulators evaluate the effectiveness of their compliance structures or investigate potential non-compliance with applicable laws and regulations frequently defer to external law firms to assist them with their investigative efforts and for advice on the potential risk of exposure to civil, regulatory and criminal liability. In what circumstances would corporations be required to waive privilege over such material, and, for certain jurisdictions, in what circumstances would this no longer be considered to be covered by privilege. For example, in a recent decision of the Swiss Federal Supreme Court ("SFSC") – 1B\_85/2016 dated 20 September 2016 – it was held that a litigious draft investigation report and notes of employees' interviews were not covered by attorney-client privilege.

#### 11:30 – 12:30 Panel 3 – Self Reporting

This panel will consider whether voluntary self-reporting is the new key to mitigating corporate liability?

In certain jurisdictions, corporates can negotiate a settlement. The US Yates Memorandum emphasised the US' renewed focus on individual corporate wrongdoing, and the need for companies to hand over evidence of individual culpability. What steps should businesses take and what are consequences for senior management and employees?

The US has traditionally been seen as leading the way with regard to self-reporting wrong doing. Earlier this year, the US Department of Justice ("Dol") announced a one-year pilot programme under which US corporations could mitigate their own liability for violations of the Foreign Corrupt Practices Act ("FCPA") by voluntarily self-disclosing FCA violations within their organisations, in addition to fully cooperating with DoJ investigations. Will this approach be adopted elsewhere?
